**SUMMARY & BACKGROUND**

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found [HERE](#).

Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. The first portion of ARP-ESSER Funds was awarded to states on March 24, 2021, and 60 days from that day is May 24, 2021. The U.S. Department of Education (USDE) has taken the position that an SEA makes allocations when it authorizes the LEA to begin to obligate funds in accordance with its needs. To enable New York State's LEAs to begin to obligate ARP-ESSER funds by USDE's May 24, 2021 deadline, the application for LEA 90% base ARP-ESSER allocations is being administered by NYSED as a two-part application process:

**ARP-ESSER Application – Part 1:** The first step was for each LEA to submit signed assurances to NYSED by May 24, 2021. Upon receipt of signed LEA assurances, NYSED provided an email notice to the LEA of substantially approvable application status. Upon receipt of such notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.

**ARP-ESSER Application – Part 2:** The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. The federal ARP statute requires SEAs to reserve:

not less than 5 percent of the total amount of grant funds awarded to the State (\$449.4 million) to carry out activities to address the impact of lost instructional time by supporting the implementation of evidence-based interventions;

not less than 1 percent (\$89.9 million) to carry out the implementation of evidence-based summer enrichment programs; and

not less than 1 percent (\$89.9 million) to carry out the implementation of evidence-based comprehensive afterschool programs.

The 2021-22 enacted state budget directs that these required SEA set-asides be allocated as grants to specified school districts. Title VIII of Division B of the CARES Act directs the Department to carry out the Education Stabilization Fund, of which the ARP ESSER funds are a part. Section 2001 of the ARP Act provides for the Department to make grants to each SEA from the ARP ESSER funds. An SEA must allocate at least 90 percent of its ARP ESSER grant funds to its LEAs (including charter schools that are LEAs) in the State in the same proportion that the LEAs received under part A of title I of the ESEA in Fiscal Year 2020, as required by section 2001(d)(1) of the ARP Act; and section 2001(e) of the ARP Act prescribes certain mandatory and permissive uses of LEAs' funds. Similar to the manner in which we engage stakeholders for the ESSA Title budgeting planning, the district announced an in-district meeting for use of ARPA funds during school (in-person meeting) and solicited parent/guardian and stakeholder engagement via email listserv to participate in a virtual presentation of our plan. Invited stakeholders included parents/guardians of day and residential students, residential agency leaders and workers, and local groups which support our instructional programs during the school year.

In the space provided below, please describe the extent to which and how the funds will be used to implement prevention and mitigation strategies that are, to the greatest extent practicable, consistent with the most recent CDC guidance on reopening schools, in order to continuously and safely open and operate schools for in-person learning.**

While funds from ARPA will not be directly used to implement prevention and mitigation strategies for safe opening and operations of in-person learning, as the district has already operated as such since July 2020, all programming supported in part of whole by ARPA funds will follow all NYS DOH-issued guidance for reopening schools. Current and future reopening plans, adopted by the LEA board of education, shall guide all operations including activities funded by ARPA.

Current prevention and mitigation strategies include compliance with all NYSDOH and local DHS mask and social distancing mandates, in addition to weekly testing of unvaccinated staff, visitors, and consultants, and collection of proof of vaccination from staff, visitors, and consultants. Schedules have been restructured to avoid large gatherings (i.e. lunches). The district is also maintaining a rigorous cleaning and disinfecting schedule in high-tough and high-traffic areas and in all classrooms and offices during after hours cleaning. Additionally, the district has improved its ventilation and circulation with upgraded filtration where applicable and planned improvements to circulation/HVAC systems.

- 4. In the space provided below, please describe the data that the LEA will use to identify student needs and monitor student progress as a result of planned interventions and supports.**

Our triannual benchmarking program, STAR Reading and STAR Math, shall serve as the primary data source for identifying students in need of additional interventions and supports, as all students enrolled participate in the fall/winter/spring benchmarking assessments. Students also undergo review team meetings to assess progress toward IEP goals, as all of our population are SWD. Additional data include NYSTP and Regents scores as applicable, or in the circumstance of the Regents cancellations, department-created mid-term and final assessments.

Students identified through the benchmarking process or other data review teams will be assigned to academic intervention-based extended school day programming staffed by certified teachers and using intervention programs including Read 180 and System 44 in addition to online portions of HMH Journeys for literacy, and GoMath, Prodigy, IKnowIt, and McGraw Hill math interventions. The extended school day learning loss sessions will be available during the regular and summer programs.

- 5. In the space provided below, please describe how the LEA will use the funds it reserves under section 2001(e)(1) - the required reserve of 20% of funds - to address the academic impact of lost instructional time through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year.**

ARPA funds will be used to support several years of extended school day programming focused on academic learning loss as a result of the pandemic, including 34 weeks in the regular school year and 6 weeks in the summer programs. ESD programming will be led by certified teaching staff who currently work in the district and are familiar with the students' needs and present performance levels.

As part of the required 20% learning loss reserve, students identified through the benchmarking and other review processes noted in previous question will be assigned to academic intervention-based extended school day programming staffed by certified teachers and using intervention programs including Read 180 and System 44 in addition to online portions of HMH Journeys for literacy, and GoMath, Prodigy, IKnowIt, and McGraw Hill math interventions. The extended school day learning loss sessions will be available during the regular and summer programs.

Outside of the required 20% to address learning loss, the majority of the remainder of ARPA funds will support additional academic and also enrichment learning opportunities in an extended school day environment. Following the same model of 34 RSY and 6 ESY weeks of ESD programming, students will have the potential to engage in an additional 500 hours of contact time throughout the year. The district will utilize ARPA and other funding sources to continue the ESD model through 2024.

Each program funded by ARPA monies will be proposed and approved by an administrator, including a description of intended outcomes and indicators of growth. These data will be reviewed by the district data team in the same manner as we review all data for our students. As a special act, all of our students are seen by PPS and mental health providers and we have been monitoring the effects of the pandemic since the school closures started in March 2020. One additional tracking element through the ARPA funds will be to track any academic regression and growth compared to the number of hours and programs attended by a student in the ESD programs.

As a special act, approximately 75% of our enrollment are residentially placed via CSE, DSS, and/or foster care/family courts. The residential placement, via screening and intake, addresses issues related to foster care, homelessness, and high need/low resource communities. As all of our population are SWDs, all students receive services as per IEPs (no SWD disproportionality). All students in our district, as a special act, are able to receive consistent services given our lower enrollment size and fully-integrated model with 8:1:1 class size ratios, allowing us to address typical disproportional impacts such as income and racial/ethnic subgroups. The district does not operate an ENL program and thus, cannot enroll ELL students.

Amendments to the plan, such as was done in June 2021 following the mask guidance updates, are acted upon by the board of education following an outreach to solicit feedback. The draft plan is sent via listserve to school and parent/guardian stakeholders and feedback may be sent to a dedicated email address for the district. Additionally, based on the amendments, we may host a virtual Q&A session for all stakeholders to provide feedback on plan updated and/or changes. This model will be followed every six months as required by law, or more frequently should updated guidance necessitate.
